PLEASE READ THE FOLLOWING NOTES BEFORE COMPLETING THIS FORM

1. Please use ink and capital letters or a typewriter to complete the application. Where a signature is called for, it must be signed by the referenced person in ink. Where a date is called for, please enter day, month & year.
2. All applicants must complete Section A, D and **EITHER** Section B **OR** Section C.
3. Unless registered with The Bahamas Kennel Club as a kennel name, a name may only be used once as either a prefix or suffix in naming dogs of Bahamian born litters. Names chosen must not contain more than 30 letters or characters including numeral affix and must consist of at least two words.
4. In order for a dog to be registered in the Stud Book it is necessary for the Registration Officer to see the **original** unrestricted (not a Limited Registration) Certificate of Registration indicating the dog's registry and owner of record issued by the Foreign Kennel Club and an **original** foreign three generation Certified Pedigree issued by the registry in the dog's country of birth (Export Pedigree). Photocopies of these documents must accompany your application and the originals provided for review prior to the BKC certificate being issued. All Foreign Kennel Clubs must be recognized by the Bahamas Kennel Club. All dogs applying for Stud Book Registration must be **INTACT**.
5. In the case of purebred dogs imported to participate in a BKC show only, please complete an application as indicated in 2. & 4. except it is not necessary to provide the three generation Certified Pedigree as indicated in 4. above.
6. Dogs for whom the documents in 4. above are unobtainable may be given an **INITIAL REGISTRATION** i.e. they will be registered but not eligible for the Stud Book. Further details may be obtained from the Registration Officer, Bahamas Kennel Club, P.O. Box N-9870, Nassau, Bahamas
7. Owners of purebred dogs born in the Bahamas whose Sire & Dam were not previously registered with the BKC must provide the information called for in 2. & 4. above for both Sire & Dam if they are applying for Stud Book Registration.
8. All Potcakes must be seen by The Bahamas Kennel Club Official Standard Committee prior to registration. Further details may be obtained from the Bahamas Kennel Club, P.O. Box N-9870, Nassau, Bahamas.
9. Persons availing themselves of the registration facilities of The Bahamas Kennel Club shall be deemed to have agreed to the authority of the Club and its Board of Governors.
10. Forward this Application, with supporting documents and correct fee to: The Registration Officer, Bahamas Kennel Club, P.O. Box N-9870, Nassau, Bahamas.
11. The Bahamas Kennel Club reserves the right to reject any application to register a dog, a Kennel Name or transfer any dog or to change or cancel or suspend any registration and may cancel or suspend any registration or transfer or grant of a Kennel Name already made. The acceptance of a registration is not a guarantee of its accuracy.
12. When submitted, this application becomes the property of the Bahamas Kennel Club

FEES All fees for transactions requiring the services of the Registration Officer shall be made payable to THE BAHAMAS KENNEL CLUB and must accompany the application. They may be in the form of a post office money order, bank money order or cheque payable at par at Nassau, Bahamas.
